Nomination Procedures

Members of the United States Congress are asked each year to make military academy nominations. I am pleased to receive applications from students in Indiana's Fourth Congressional District for nominations to one of the US Service Academies: the U.S. Air Force Academy; the U.S. Naval Academy; the U.S. Merchant Marine Academy; and the U.S. Military Academy. Without a doubt, the military academies are some of the finest schools in our nation.

To be considered for a nomination, applicants must be legal residents of the Fourth Congressional District of Indiana. I will accept applications from candidates who will graduate from high school in 2023 or from those who have already graduated. To apply for a nomination, the following eligibility requirements must be met by each applicant as of July 1 of the year of admission to the service academy:

- Must be a U.S. citizen and a legal resident of the Fourth Congressional District
- Be unmarried, not pregnant, and have no legal obligations to support children or other dependents
- Must be at least 17 years old, but not yet 23 years old

Service Academy admission is a two- tiered process. First, the applicant must apply directly to the Academy and meet the set minimum standards. These standards include, but are not limited to physical, medical, and academic qualifications. Second, applicants must pursue admissions through the Nominations process. It is the responsibility of each potential applicant to contact and initiate a pre-candidate file at each academy they wish to seek a nomination.

An individual must receive a Congressional Nomination, as well as, meet the set requirements for the Academy to be offered an appointment. Also, those who may receive a nomination are NOT guaranteed to be offered an appointment by an Academy.

Anyone who has an interest in attending one of the Service Academies, for the 2023 - 2024 academic year, must submit all their information, to my office, by November 10, 2023. The deadline for applications to be received is November 10, 2023. All applications and all required materials NEED to be postmarked or received by this date, or the application will be considered incomplete and therefore will NOT be accepted. Please submit fully completed applications to my Academy Coordinator in my Danville District Office located at 355 South Washington Street, Suite 210, Danville, IN 46122. Once all required materials have been received, the applicant will receive a letter of confirmation from my office.

In addition to the application, several items are needed to complete your candidate packet. These items include:

<u>Resume</u>

- A resume of extracurricular activities, athletic activities, community activities, employment history and notable accomplishments. The more details you can provide in your resume, the better.

Three Letters of Recommendation

- Persons used as references should not be related to applicant
- Can be teacher, counselor, coach, employee, clergy, scout leader
- One letter MUST be from high school administrator or teacher

<u>Essay</u>

- Essay must be no longer than one page, double spaced, detailing your desire to attend a service academy, and therefore being commissioned as an officer

Official Copy of SAT/ACT Score

- Applicants need to take the SAT/ACT at least once, prior to the deadline
- Completed scores/results should be sent to my Danville District Office

Official Academic Transcripts

Applicant needs to submit certified high school transcript or most recent college/preparatory school transcript, which needs to include class rank, GPA, and Fall 2021 course load.

<u>Photo</u>

- A tasteful and updated photo of yourself.
